- we accept the eventual possibility of body temperature measurement from Andalo Gestioni S.r.l. staff;
- to access the following facilities/attractions: **ACQUAPARK ACQUAIN, ACQUAIN WELLNESS&SPA, CINEMA, ICE RINK, WINTER PARK, FITNESS GYM, MINIATURES AND NATIVITY SCENES EXHIBITION, MINICLUB, EVENTS** we'll present at the counter the valid GREEN PASS accompanied by an identity document (except for exempt persons as per specification of the Art.3 Comma 3 del D.L. 23rd July 2021, nr 105 that will present valid medical certification).

## **INFORMATION ON THE PROCESSING OF PERSONAL DATA**

*In accordance with Regulation UE 16/679 we hereby provide information regarding the processing of personal data of individuals who, during the Covid-19 emergency, access our facilities and are required to undergo the procedure of body temperature measurement or to disclose to our Corporation eventual information regarding quarantine measures, fiduciary isolation with health monitoring and/or no contacts, over the last 14 days, with subjects who tested positive for Covid-19.*

### **Owner of the processing and responsible for the protection of personal data**

Our Administration has appointed a person in charge of the protection of personal data.

### **Type of personal data processed and interested parties**

Within the limits of the purposes and the modalities defined by this policy, the following data are being processed:

- A) Personal data and data regarding the body temperature of the interested party, detected or attested
- B) Personal data regarding quarantine measures, fiduciary isolation with health monitoring and/or no contacts, over the last 14 days, with subjects who tested positive for COVID-19.

Personal data subject to processing regard:

- A) Our staff and our collaborators (regarding these interested parties, the present policy incorporates the one already provided for the processing of personal data functional to the establishment and the execution of the employment relationship)
- B) Suppliers, contractors, clients and other third parties who are authorized to access our premises, facilities and offices.

### **Purposes and legal basis of the processing**

Personal data will be processed exclusively for purposes of prevention from Covid-19 contagion. The legal basis of their processing is represented by public safety purposes.

### **Nature of the provision of personal data**

The provision of data and their processing are necessary to access our premises, facilities and offices. An eventual refusal to provide them will prevent you from accessing.

### **Terms, scope and duration of the processing**

The processing is carried out by members of the staff in charge, who act based on specific instructions provided with respect to the purposes and methods of the processing. Regarding the eventual possibility of body temperature measurement, the owner of the processing doesn't record any data whenever the temperature is lower than 37.5 C. The identification of the interested person and the recording of the exceedance of the temperature threshold may occur whenever it is necessary to document the reasons that prevented the access. In this case the interested party will be informed. Personal data will not be disclosed, nor communicated to third parties, except in virtue of specific regulatory provisions (i.e. Health Authority to reconstruct the chain of eventual close contacts of a worker/client guest who tested positive for COVID-19). Data will be processed for the time strictly necessary to achieve the envisaged purpose of prevention from COVID-19 contagion and they will be stored not further than the end of the aforementioned state of emergency.

### **Rights of data subjects**

At any moment, the data subjects have the right to access their personal data, to request the rectification, the update and the erasure whenever foreseen. It is furthermore possible to object to the processing and request the limitation. These requests may be addressed directly to the owner of the processing, at the addresses indicated above. Moreover, if it appears that the processing has been carried out in contravention of the regulation on the protection of personal data, the right to file a complaint to the Guarantor Authority for the protection of personal data, Piazza Venezia, 11-00187 – Rome, [urp@gdp.it](mailto:urp@gdp.it) is granted.
